SC forms task force on doctors' safety

Slams West Bengal govt over delay in filing FIR in Kolkata doctor's rape-and-murder

New Delhi, July 16

A landmark decision by the Supreme Court on Tuesday slammed West Bengal government over its delay in filing a First Information Report (FIR) in the rape and murder of a doctor at Kolkata's Dr Biju Medical College and Hospital. The Supreme Court (SC), which took up a writ petition filed by the doctor's wife, ordered a 10-member national task force (NTF) on Tuesday.

The task force, comprising senior doctors, will develop a national protocol to ensure the safety and facilities for health care workers at their workplaces. This would potentially bring in major reforms in the working conditions for medical practitioners and paraprofessionals.

The three-judge bench, led by Chief Justice of India (CJI) D.Y. Chandrachud, said, "We are establishing an NTF with doctors from diverse backgrounds who will prepare a blueprint to be implemented nationwide to ensure the safety conditions are maintained and that doctors, whether young or middle-aged, are safe in their work environment."

The bench directed the task force to examine and recommend measures for the safety and well-being of medical professionals. It was also asked to prepare a national action plan for preventing gender-based violence and ensuring safe and dignified working conditions for women, resident doctors, and non-resident doctors.

The task force has been asked to submit an interim report within three weeks and a final report within two months of the order.

Two 4-yr-old girls sexually abused: Protesters block railway tracks in Thane

Thane district protesters blocked the railway tracks at Bandra-Powai station in Thane district and demanded a school be opened after the sexual abuse of two 4-year-old girls by a resident doctor at the station.

Police were charged the protesters, who occupied the railway tracks, getting down at Bandra-Powai station, and the school building to express their demands over the sexual abuse.

Mathurani District Chief Minister Dhanraj Dhanraj said he has formed a task force to investigate the allegations of sexual abuse and to ensure the safety of children. He also said that the school will be opened after the investigation is complete.

The protesters, who were led by a woman, said that the school should be opened immediately and that the doctor should be punished. They also demanded that the police should take strict action against the doctor.

Medical bodies welcome order; strike on until protection Act is enacted

Medical bodies of a 100-member doctors' associations (MDA) welcomed the Supreme Court (SC) decision to form a task force to study the safety of health care workers at their workplaces. The Indian Medical Association held a meeting with state presidents and secretaries on Tuesday to determine the next steps.

While welcoming the apex court's order, the Federation of All India Medical Associations said that it had a meeting with an associated body and decided to continue protest until a central protection Act for the safety of health care professionals is enacted. This follows the SC's request for doctors to resume work.
