SC forms task force on doctors' safety

Slams West Bengal govt over delay in filing FIR in Kolkata doctor's rape-and-murder

A landmark decision by the Supreme Court on Tuesday slammed West Bengal government over its delay in filing a First Information Report (FIR) in Kolkata doctor's rape-and-murder case.

The task force, comprising senior doctors, will develop a national protocol to ensure the safety and facilities for health care workers at their workplaces. This would potentially bring in major reforms in the working conditions for medical practitioners and paraprofessionals.

The three-judge bench, led by Chief Justice of India P.D. Dinkar, said, "We are establishing an NTP with doctors from diverse backgrounds who will prepare guidelines to be implemented nationwide to ensure the safety conditions are maintained and that doctors, whether young or middle-aged, are safe in their work environment."

The bench directed the task force to examine and recommend measures for the safety and well-being of medical professionals. It was also asked to prepare a national action plan for preventing gender-based violence and ensuring safe and dignified working conditions for women, resident doctors, and non-resident doctors.

The task force has been asked to submit an interim report within three weeks and a final report within two months of the order.

Medical bodies welcome order; strike on until protection Act is enacted

Medical bodies and related doctors' associations (MBA) welcomed the Supreme Court's (SC) decision to form a task force to study the safety of health care workers at their workplaces. The Indian Medical Association held a meeting with state presidents and secretaries on Tuesday to determine the next steps.

While welcoming the apex court's order, the Federation of All India Medical Associations said that it had a meeting with an appointed SC-appointed committee to discuss the safety of health care professionals is essential. This follows the SC's request for doctors to resume work.

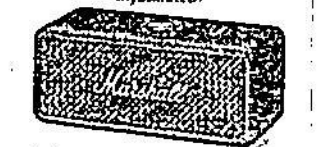
